

Access Provider Policy (2022-2023)

1. Introduction

This policy statement sets out the school's arrangements for managing the access of providers to students at the Academy for the purposes of giving them information about the provider's education or training offer. This complies with Uxbridge High's legal obligations under Section 42B of the Education Act 1997.

2. Student entitlement

Students in years 8-11 are entitled:

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options evenings, assemblies and group discussions and taster events;
- to understand how to make applications for the full range of academic and technical course.

3. Management of provider access requests

3.1 Procedure

3.2 Opportunities for access

A number of events, integrated into the school careers programme, will offer providers an opportunity to speak to students and/or their parents face to face or virtually. (See Appendix 1).

Under the school's child protection and safeguarding policy, we ask providers who will have the opportunity for regular contact with children to have a DBS check in place. They will also be subject to reasonable supervision.

4. Premises and facilities

The school will make the appropriate face to face or virtual arrangements and all will be discussed and agreed in advance with the careers leader. Providers are welcome to leave a copy of their prospectus or other relevant course literature for the careers library/webpage. The library/webpage is available to students at lunch, break time and after school, as well as during 1:1 guidance interviews.
